## Explanation of Responses:

- Represents (i) 81,818 restricted share units ("RSUs") granted on July 2, 2024, 25% of which vest on July 29, 2026, and the remaining 75% vest in equal quarterly installments of 6.25% thereafter, all of which remain unvested as of March 18, 2026, (ii) 43,416 RSUs granted on November 5, 2025, 25% of which vest on November 5, 2026, and the remaining 75% vesting in equal quarterly installments of 6.25% thereafter, all of which remain unvested as of March 18, 2026, and (iii) 19,381 RSUs granted on March 16, 2026, 25% of which vest on March 16, 2027 and the remaining 75% vest in equal quarterly installments of 6.25% thereafter, all of which remain unvested as of March 18, 2026.
- The options were granted on September 6, 2020, 25% of which vested on September 6, 2021, and the remaining 75% vested in equal quarterly installments of 6.25% thereafter. As of March 18, 2026, all 50,000 options are fully vested.
- The options were granted with an exercise price of NIS 4.84 per share. For purposes of this Form 3, the exercise price has been converted into U.S. dollars using an exchange rate of NIS 3.10 to USD \$1.00 as of March 11, 2026, resulting in an exercise price of \$1.56 per share.
- The options were granted on April 28, 2021, 25% of which vested on April 28, 2022, and the remaining 75% vested in equal quarterly installments of 6.25% thereafter. As of March 18, 2026, all 385 options are fully vested.
